



## Delaware Survey Results

**Q1** When driving, which of the following do you consider an emergency vehicle- only first responder vehicles such as police, fire and ambulances; only rescue vehicles such as tow trucks; only working vehicles such as construction and utility trucks; both first responder AND rescue vehicles; or, all of these?

- Only first responder vehicles such as police, fire and ambulances*..... 45%
